

Fees for Green Seal Certification under GS-42 Standard for Commercial Cleaning Services

Green Seal's fees are based on the number of accounts cleaned by the service and the applicant's total annual sales/revenue. The fees reflect the basic cost of evaluating, certifying, and monitoring cleaning services under a contractual application and license agreement with Green Seal, Inc. As a 501(c)(3) non-profit organization, Green Seal uses the revenue from fees to help us realize our mission to create a more sustainable world.

Evaluation and Monitoring Fees

Evaluation for Certification

Each service is evaluated to verify that it meets the GS-42 standard. The full evaluation fee is due at the time of application. The evaluation fee covers the evaluation of the service's products used, procedures, training, communications, and materials and literature that include reference to Green Seal. Out-of-pocket costs, such as costs for travel for an on-site audit, are not included in the evaluation fee. The base fee includes auditing one account; additional account audits may be required and incur additional fees.

Evaluation Fees

Compliance Monitoring

Once a cleaning service is certified, periodic compliance monitoring is conducted to ensure that the requirements for certification are still being met. Monitoring involves a review of the service and ancillary materials similar to the initial certification evaluation, and may include on-site audits of different accounts being serviced according to GS-42 requirements. Compliance monitoring fees include the review, and the 12-month license to use the Green Seal Mark, and are due annually on or before the anniversary of certification.

Evaluation Fees for Cleaning Services


An "Account" is one location based on unique attributes, and may describe a single building, a building complex or a campus. The evaluation fee includes **one on-site audit**; additional account audit requirements are described below. Out-of-pocket costs, such as costs for travel for an on-site audit, are not included in the evaluation fee. Contact us for more information.

<u>Tier III</u>	Evaluation Fee for One Account	
Annual sales/revenue \$500,000 to \$1 million	\$5,700	
<u>Tier II</u>	Evaluation Fee for One Account	
Annual sales/revenue \$1 million to \$5 million	\$7,000	
<u>Tier I</u>	Evaluation Fee for One Account	
Annual sales/revenue \$5 million or over	\$7,500	

Account Audit Requirements

Because different accounts can require different procedures, it is necessary to audit more than one account being serviced according to GS-42 requirements. The account audit requirement is based on the number of accounts receiving the GS-42 service from the service provider. Green Seal reserves the option to visit up to a maximum of 5% of the accounts cleaned.
